Section 1: Vision, Mission, Objectives and Functions

Vision

To be a Center of Excellence in Asia on urban development issues and to support sustainable and inclusive urban development in India

Mission

To be a knowledge center of research, training and information dissemination in urban development and management

Objectives

1. To facilitate research on urban issues for formulating urban policies and sustainable urban development programmes
2. Coordinate research and carry out evaluation and appraisal of urban development programmes
3. To disseminate and support exchange of information on innovations, best practices and reforms in the field of urban development
4. Capacity building and training of functionaries on pressing urban issues

Functions

1. Preparation of comprehensive frame of reference for policy and programme oriented urban research in India;
2. To undertake and coordinate research; to promote effective utilization of emerging knowledge through programmes of Government of India such as JnNURM, UIDSSMT and capacity building of satellite towns. The results and its application to field problems; relating research to the practical problems of urban areas; and action research for programme formulation and implementation;
3. Projecting the perspectives of integrated rural-urban planning and development to the general public and the decision makers - both administrative and legislative - and also providing necessary forum by arranging seminars and

workshops and other means, for an objective discussion with a view to evolve policies and programmes for meeting the new challenges; and

4. Collection, analysis and dissemination of information and intelligence on rural-urban processes through various communication channels including the publication of a journal; and maintenance of website.

- Coordinate data compilation on ‘Impact of 74th CAA on Working of ULBs’ along with IIPA, and RCUES, Lucknow/Hyderabad/Mumbai.
- Provide research support to MOUD to respond to policies, reports, notes and proposals received from Parliament Committees, State Governments, ULBs, Government Departments/Parastatals, NGOs, and others.
- Support JNNURM in terms of: (i) coordination of PEARL, (ii) Reform Appraisal, (iii) MIS, (iv) TAG, etc.
- Publish Urban India Journals (bi-annual).
- Disseminate information about MOUD’s programmes and projects through newsletters and websites.
- Follow up of the 13 CFC recommendations
- Capacity Building Training Programme in JNNURM and UD Sectors, etc. to be undertaken on e-governance, accounting and property tax.

Proposed measurement: Percentage of the study completed.

2. Completion of the research projects: Success indicator is defined as timely completion of research studies.

Proposed measurement: Percentage of the study completed.

3. Capacity Building: Success indicator is defined as the total number of persons trained in the workshops. Since it is difficult to devise a method for measurement of efficient training.

4. Reform Appraisal: Success indicator is defined as the number of reports submitted based on the field visits and analysis of secondary information.
